The purpose of the meeting was to receive information regarding employees, collective bargaining and pending litigation. The executive session ended at 7:35 p.m. with no action being taken.
3. The board then moved into a duly advertised regular meeting of the Board of Education that was called to order by President Buddy Bosler at 7:45 p.m. in the North Harrison Middle School Cafeteria.
4. Secretary Robert Chinn polled the Board and found that all members were present.
5. Mr. Ron Coleman moved and Mr. Robert Chinn seconded a motion to approve the minutes of the March 8, 2007 regular meeting and March 22, 2007 executive session. The motion passed with a unanimous vote.
6. Mr. Robert Chinn asked about the Rennirt Septic Service statement.
7. Assistant Superintendent Ken Oppel explained the Rennirt Septic Service statement.
8. Mr. Buddy Bosler asked about the transportation fleet card payment to Uhl Truck Sales.

15. Mr. Fred Naegele moved and Mr. Robert Chinn seconded a motion to appoint Sarah Burgher as counselor at North Harrison Middle School and Traci Kerns as boy's assistant track coach at North Harrison High School. The motion passed with a unanimous vote.
16. Mr. Robert Chinn moved and Mr. Gary Byrne seconded a motion to approve a \$690.00 donation from First Harrison Bank for Morgan Elementary School 4th grade field trip to Conner Prairie (no match required). The motion passed with a unanimous vote.
17. Mr. Gary Byrne moved and Mr. Ron Coleman seconded a motion to appoint Mr. Robert Chinn as the Board's representative to the Harrison County Alternative School Board. The motion passed 4-0-1 with Mr. Chinn abstaining.
18. Mr. Fred Naegele asked why the school corporation does not have professional development days on Fridays.
19. Superintendent Monty Schneider explained the philosophy of professional development days and how they are assigned to the school calendar.
20. Assistant Superintendent Ken Oppel explained 2-hour delays and how such a delay could cancel a professional development day.
